Community Square- looks poor; Ian wrote to Rob Forsythe in November re planting, coping stones, weeds, need for benches but no response received; back of shop cleared up by new owner & Sue Lester, PCSO involved; York stone fragmenting in severe weather

Wirksworth Clean Streets meeting – Mike & members of group going to see Peter Foley, Commercial Services HoD & group has written to Chief Constable asking about on the spot fines

Street cleaning – Ian contacted Rob Forsythe re litter around Hannages & Coldwell Street, having collected rubbish himself & requested more frequent service; hedge in front of Fanny Shaw & cemetery lodge full of rubbish; received positive response; also contacted My Street; only Cemetery Lodge cleared; recycling area in Wheatsheaf car park also a mess. Town no longer has dedicated street cleaner due to illness, so not same level of care

Church Walk

Copies of rejection letter from Jeremy Fenn, officer at HLF circulated & discussed; raised at DDDC meeting last week & Leader of Council, Lewis Rose responded; DDDC had made an investment in project by sending officer to Church Walk Group; DDDC accepts responsibility for repair & maintenance of railings as far as it is able

Boulderflatts Mine – owner applied for certificates of use for construction of agricultural buildings – enormous glass buildings – DDDC refused certificate

Hannage footpath – AGS Foundation Governors have project to improve footpath on perimeter of school to Coldwell Street with new fencing & sculpture trail & is looking for support from DDDC & Town Council

Crown Square, Matlock – information circulated by DDDC

Waltham House – had to apply for change of use to restaurant as there is more community use than previously intended

Dales Housing

Proposed major development Wash Green/King Edward Street – Graham attended exhibition 7th September; approx 14 houses to be sited at back of King Edward Street; good use of unused ground but could be difficult to integrate further houses; concern regarding addition cars using Wash Green where parking creates difficulties; more refuge areas needed for passing cars; situation requires improved management

Transition Wirksworth

Transition Town -utilising a town`s resources and expertise in order to be resilient against the pressures of oil and other fuels running out.
